



BMC UPDATE ON PORT PROTOCOLS IN INDIA

Further to our note on the protocols being followed by various ports in India in light of the Coronavirus (COVID -19) pandemic, please find hereunder an update on the functioning of the ports for your ease of reference.

As per our last update [see link], various Orders from the **Ministry of Home Affairs**, Government of India, the **Ministry of Shipping**, Government of India and the **Directorate General of Shipping**, India (“**DG Shipping**”) had clarified that ports are open and functioning for cargo movement, with all traffic being subject to the screening protocols set out by various ports and DG Shipping. Further, it had been clarified that transportation of all goods, without distinction of essential and non-essential, have been allowed.

Subsequently, the **Ministry of Home Affairs**, by an **Order dated 14th April 2020** extended the nationwide lockdown until 4th May 2020 and issued revised guidelines on what would be permitted from the week commencing on 20th April 2020. Whilst the port operations were always outside the lockdown restrictions, the revised guidelines clarified that operations of seaports and inland container depots (ICDs) for cargo transport, including authorized custom clearing and forwarding agents were allowed. Following up with the extension of the nationwide lockdown the **Ministry of Shipping**, Government of India vide **Directive dated 21st April 2020** issued directions to Major Ports in India to remain fully operational and also called for certain remission of charges by the ports to its users.

The Ministry of Home Affairs, Government of India vide its clarification dated 21st April 2020 also permitted the Sign-on and sign-off of Indian Seafarers at Indian Ports and their movement as per the SOP provided by **DGS Order 12 of 2020 dated 22nd April 2020**. The DG Shipping subsequently realized that there are certain issues being faced by Indian seafarers at the time of sign on and sign off and therefore has also issued an FAQ to assist the seafarers, shipowners and agents.

Please also note that the **Ministry of Home Affairs**, Government of India by way of its **Order dated 1st May 2020** has further extended the lockdown by two weeks, commencing from 4th May 2020 till 17th May 2020 [see update on the extension of the lockdown], however, this has not affected port operations. The extended lockdown now divides the country into various zones depending on the severity of the outbreak and has permitted certain activities, whilst restricting others, for each of the said zones. The State/Union territories have also been

NOTE ON PROTOCOLS IN INDIA – UPDATE

Further to our note on the protocols being followed by various ports in India in light of the Coronavirus (COVID -19) pandemic, please find hereunder an update on the functioning of the ports for your ease of reference.
