## **ADDITIONAL PREMIUM AREAS**

In accordance with the provision of Rule 19.4 we hereby give you notice that your Directors have determined in exercise of their powers under Rules 19.3 and 19.3.1 that the Additional Premium Areas shall be amended as follows.

The following area is amended:

(A) Iraq is amended to read "Persian or Arabian Gulf and adjacent waters including the Gulf of Oman North of 24degrees North".

The following areas are added:

- (M) Gulf of Aqaba and The Red Sea.
- (N) Yemen/Peoples Republic of Yemen (North and South Yemen).
- (O) Pakistan.
- (P) Oman.
- (Q) Syria.
- (R) Algeria.
- (S) Egypt.

This notice is effective from 2400 hours GMT on 21 September 2001 and on the expiry of 7 days thereafter, effective from 2400 GMT 28 September 2001, your terms of entry will incorporate the foregoing amendment and additions.

For your guidance, as from 2400 GMT on 28 September 2001 the full list of Additional Premium Areas will be as follows:
