# NorthStandard – Name Change

As part of our integration following completion of the merger to create NorthStandard on 20 February 2023, we have changed the name of "North of England P&I DAC" to "NorthStandard EU DAC" with effect from 6 October 2023.

## What's changing

From 6 October 2023, our Irish insurance company, North of England P&I DAC, has changed its name to **NorthStandard EU DAC**.

This is purely a name change of the company and will only be relevant to those members and policyholders who are insured by North of England P&I DAC. Details of your insurer can be found in your insurance documentation.

There will be **NO** change to the terms of the underlying insurance business written by North of England P&I DAC other than the name change.

All the other insurance companies within the NorthStandard group will continue to use their existing names and provide their current services.
